


Calls to action

- **An die Bundesverwaltung:** Forschungsergebnisse begreifbar kommunizieren und klare Zielvereinbarungen in den Branchen vereinbaren.
- **An das Parlament:** Das BAFU braucht ein stärkeres Mandat zur Erarbeitung und Durchsetzung von Zielvereinbarungen und Branchenabkommen.

The potentials of nudging and voluntary agreements to steer company behaviour

In this session we will explore the potential of nudging and voluntary agreements in the private sector for the transition towards a sustainable economy. The NRP 73 research project [Nudging SMEs](#) of Dr. Jan Schmitz uses behavioural experiments to study company decisions and to test whether and how nudging can be applied to steer company behaviour. The research project from Prof. Dr Thomas Bernauer [Voluntary Corporate Environmental Initiatives](#) investigates the interplay between voluntary business initiatives and state intervention from a public opinion perspective.

- Discussion of the implications for companies and policy making
- Exploring the role of nudging and voluntary agreements in the private sector and the impact on the appropriate policy mix
- Formulate three calls to action and address them to specific stakeholders
